## Lawful bases and data protection rights

## How long we keep information

We will retain your personal data only for as long as necessary to fulfil the purposes for which we have collected it. For example, retaining your contact information while you are subscribed to our newsletter until you ask to be unsubscribed. For grants, donation, and shop related data-collection, we keep the record for six years from the end of the financial year the transaction took place due to HMRC tax audit requirements.
